To help you meet this requirement, the Evanston Health Department is pleased to once again sponsor the Illinois Food Service Managers Initial and Refresher Certification course.

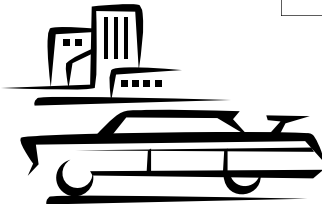
INFORMATION ABOUT THE OCTOBER 2008 CLASSES

Be sure to bring a Photo ID and arrive on time.

Initial Certification. \$100 (includes book)
 Class is WED & THURS, Oct 8 & 9, 8:30am—5pm. (1 hour lunch break)
 Exam begins at 9AM on FRI, Oct 10.
 REGISTRATION: Wednesday, 8:00am—8:30am
 You must show a photo ID, arrive by 8:45, stay until 5 and pass the exam with a score of at least 75% to be eligible to receive the initial certification.

Refresher for Certificate Holders. \$50 (no book)
 Class is THURS, Oct 9, 8:30am—2:30pm. No exam. (1 hour lunch break).
 REGISTRATION: Thursday, 8:00am—8:30am
 Note: Your certificate must be current through the date of this course.
 You must show a photo ID, arrive by 8:45 and stay the entire time to receive credit.

***Exam Re-Take. No Charge** (no book)
 *Only available to you if you failed the initial exam less than 6 months ago.
 Exam begins 9am on FRI, Oct 10.
 You must bring the letter from the State indicating you need to re-take the exam.
 You must show a photo ID.
