Eligible Landmarks & Districts

The Evanston Preservation Commission is empowered to conduct an ongoing survey of the City in order to identify historically, architecturally, culturally, or archaeologically significant districts, sites, buildings, structures, and objects (Code Section 2-8-3 (G) (1). Additionally, the Commission is responsible for preparing an ongoing study list of areas, properties, structures, sites, or objects eligible for designation as landmarks or historic districts (Code Section 2-8-3 (G) (26). By placing resources on the eligible study list, the Commission is identifying them as historically, architecturally, culturally, or archaeologically significant (Code Section 2-8-3 (G) (20), and thereby putting them forward for consideration by those identified in Code Section 2-8-5 (A) for future nomination and designation. Resources placed on the study list thereby have reasonable assurances that the property can receive a favorable recommendation and report by the Commission for final consideration by the City Council.

The Commission is further empowered to review and make advisory comments on any matter affecting historically, architecturally, culturally, or archaeologically significant areas, sites, structures, and objects by way of written or verbal testimony given to appropriate Boards or Commissions including the City's Land Use Commission (Code Section 2-8-3 (G) (20). Additionally, the Commission is empowered to review and comment on any City project or activity that affects city-owned property already designated as a landmark or historic district, or determined eligible for designation (Code Section 2-8-3 (G) (24). In this way, the study list attempts to decommodify the City's significant but not registered built environment – ensuring that historic and cultural considerations and the existing quality of human scaled patterns of development are adequately included in the City's entitlement and development considerations. Equally important, this process creates space for Evanstonians to review and determine what resources from our past are important and should continue to be part of our future. **Properties listed as proposed landmarks and districts on the study list do not require a Certificate of Appropriateness.**

The following resources have been identified by the Preservation Commission as eligible and are hereby recognized as having combinations of architectural, cultural, social, or historical significance, or more broadly being representative of irreplaceable built fabric which provides the desired physical context and traditional character of Evanston as well as curiosity in material compositions and forms not commonly found in new construction and associated with Evanston's identity and collective memory of place.
