

You are hereby notified that the above-designated Municipal Officers Electoral Board is required by law to meet and pass on objections to nomination papers of candidates in the City of Evanston, to be voted on at the Gubernatorial General Election to be held on November 6, 2018.

You are further notified that the above-designated Municipal Officers Electoral Board shall meet on August 21, 2018, at 4:00 p.m., at the Lighthouse Conference Room, Room 2404, Lorraine Morton Civic Center, 2100 Ridge Avenue, Evanston, IL 60201, for the purpose of hearing and passing on said objections to the petition, and that a Call has been and is hereby made by the Municipal Officers Electoral Board for said meeting to be held at the time and place and for the purpose stated above. If you are the objector and you do not appear for the hearing at the above time and place, a default judgment may be entered against you resulting in a finding that the petition is valid. If you are the petitioner and you do not appear for the hearing at the above time and place, a default judgment may be entered against you resulting in a finding that the petition is invalid.
